STATUTORY REQUIREMENTS:

- 1. AUTHORIZED BY GOVERNING BODY
- 2. PURPOSE, TERMS, RIGHTS, AND DUTIES
- "EACH PARTY PAYING FOR THE PERFORMANCE OF GOVERNMENTAL REVENUES." FUNCTIONS OR SERVICES MUST MAKE THOSE PAYMENTS FROM CURRENT

MEMORANDUM OF UNDERSTANDING

WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER 2, ON BEHALF OF THE BASS HOLE LAKE POLICE DEPARTMENT (HEREAFTER "LAKE".) GOVERNMENT CODE) BY THE CITY OF LUBBOCK, TEXAS, ON BEHALF OF ITS POLICE DEPARTMENT (HEREAFTER "CITY"), AND THE LUBBOCK COUNTY THIS AGREEMENT IS ENTERED INTO IN ACCORDANCE WITH THE PROVISIONS OF THE INTERLOCAL COOPERATION ACT (CHAPTER 791 OF THE TEXAS

POLICE PURPOSE: THE PURPOSE OF THIS INTERLOCAL AGREEMENT IS TO PROVIDE FOR RADIO COMMUNICATIONS BETWEEN THE OFFICERS AND BETWEEN THE LAKE'S POLICE OFFICERS AND OFFICERS OF THE LUBBOCK POLICE DEPARTMENT OFFICERS OH THE LAKE'S

POLICIES AND PROCEDURES TERMS: LAKE WILL COMPLY OF THE LUBBOCK POLICE WITH THE POLICIES AND DEPARTMENT RADIO COMMUNICATIONS MANUAL (2016), ATTACHED HERETO PROCEDURES FOR USE OF THE CITY'S COMMUNICATIONS SYSTEM, AS SET AS EXHIBIT A FORTH

RIGHTS: LAKE SHALL BE ENTITLED TO USE THE CITY'S RADIO COMMUNICATION FREQUENCIES AS A SUB-LICENSEE AND SHALL BE TRANSMIT AND RECEIVE OFFICIAL LAW ENFORCEMENT VOICE AND DATA COMMUNICATIONS PERMITTED TO

COMMUNICATION FREQUENCIES. PROGRAMMING DUTIES: CITY SHALL MAKE AVAILABLE TO THE LAKE'S COMMUNICATION EQUIPMENT SO THAT IT IS CAPABLE OF TRANSMITTING AND RECEIVING ON THE CITY'S RADIO CITY SHALL EQUIPMENT NOT BE RESPONSIBLE FOR ACQUISITION, INSTALLATION, PROGRAMMING OR MAINTENANCE THE LAKE ACCESS TO THE CITY'S RADIO COMMUNICATION FREQUENCIES AND SHALL ASSIST THE OF THE LAKE'S LAKE HZ

REVENUES FUNDING: EACH PARTY PAYING FOR THE PERFORMANCE OF GOVERNMENTAL FUNCTIONS OR SERVICES MUST MAKE THOSE PAYMENTS FROM CURRENT

CHIEF OF POLICE; AND TO THE LAKE BY SERVING THE SECRETARY OF THE LUBBOCK COUNTY WATER CONTROL AND IMPROVEMENT NOTICES: NOTICES POB 1234, VILLAGE OF BASS HOLE LAKE, LUBBOCK, TX 79401, WITH A COPY TO THE BASS HOLE LAKE CHIEF OF POLICE TO THE CITY SHALL BE BY SERVING THE CITY SECRETARY, POB 2000, LUBBOCK, TX 79457, WITH A COPY DISTRICT NUMBER TO THE LUBBOCK




