



WHAT IS INCIVILITY?

- A rude or discourteous act

Sandra Day O'Connor:

More civility and greater professionalism can only enhance the pleasure lawyers find in practice, increase the effectiveness of our system of justice, and improve the public's perception of lawyers.

Kim v. Westmoore Partners (2011) 201 Cal. App. 4th 267, 293, review denied, 2012 Cal. Lexis 2232 (2012).

"Our profession is rife with cynicism awash in incivility. Lawyers and judges of our generation spend a great deal of time lamenting the loss of a golden age when lawyers treated each other with respect and courtesy. It's time to stop talking about the problem and act on it. For decades, our profession has given lip service to civility. All we have gotten from it is tired lips. We have reluctantly concluded lips cannot do the job; teeth are required. Those teeth will take the form of sanctions."

In Texas, there is a price to pay for cynical practices.







What do you do if your judge is uncivil?

Always be respectful, make a record

In the Matter of: Judge William M. Watkins, III 757 S.E.2d 594 (W. Va. 2013)

- 24 separate violations of 9 Canons of Code of Judicial Conduct
- <u>Lack of courtesy and civility</u>: used threats, intimidation, profanity, and shouting at litigants (could not control emotions).
- "You are telling a damn lie and you know it's a damn lie."
- Referred to a father as "the biggest jackass in this whole operation."

Socrates said, "Four things belong to a judge: to hear courteously, to answer wisely, to consider soberly, and to decide impartially."

...regulating the demeanor of a judge is a difficult task, because judges are human and may occasionally display anger or annoyance, and lawyers and litigants sometimes incite judges.

Judges must also be allowed some flexibility in criticizing the performance of lawyers who appear before them.

But a judge owes a duty to treat lawyers and litigants courteously, to hear them patiently, to study their arguments and evidence conscientiously, and to decide their cases promptly.

"When a judge fails to establish, maintain, and enforce high standards of conduct, the judge 'diminishes public confidence in the judiciary and thereby does injury to the system of government under law."

"A judge sets the standard for the administration of justice and for the practice of law in her jurisdiction. 'Citizens judge the law by what they see and hear in courts, and by character and manners of judges and lawyers." In re Wilfong, 765 S.E.2d 283 (W.Va. 2014); In re Watkins, 757 S.E.2d at 606 (W. Va. 2013)


I am sorry that the city required my presence at the debacle noted immediately above. And, I am sorry that this debacle managed to uproot some more of my trees.






Judge Fred Biery's Non-Kumbaya Order
